## 1. AIRPORT CHARGES

### Aircraft charges

Payable for each landing and each take off. They are calculated based on the Maximum Take Off Weight (MTOW), as indicated in the aircraft Airworthiness Certificate and in the associated Noise Certificate.

#### 1.1 Landing charges (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

#### 1.2 Take-off charges (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

They are the same as those applied to landing.

### Surcharges

General Aviation landing and take-off charges are doubled (Law no. 656 of 30<sup>th</sup> November 1994).

#### 1.3 Parking charges (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

They are due for the recovery or uncovered parking of aircraft of any type. They are calculated on the maximum take-off weight as shown in the certificate of airworthiness and for each hour or fraction of an hour after the first two hours that are free of charge

**Passenger charges**

Charges are due for the use of facilities and premises for common use that are needed for the boarding, disembarking, and welcoming of passengers. The fees are due by the travelling passengers and are levied directly by the Carrier. Charges are also due by passengers travelling on private and tourist aircraft

**1.4 Passenger boarding charges** (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

For boarding passengers travelling to domestic and European Union destinations

**Exemptions**

The following are exempted from payment:

- children under 2 years of age
- passenger boarding charge is not due for the continuation of an interrupted journey when the disruption is due to the aircraft being changed or to a circumstance beyond the passenger's control.
- domestic flights with a change of aircraft and flight number are subject to payment of the passenger charges at both the originating airport and the connecting airport; however, the fee is due only at the originating airport when the subsequent leg of the journey represents a continuation of the journey with departure on the first connecting flight
- airlines' crew members having their operating base at a given airport that must reach another airport for operational reasons (*Crew Must Go*); airlines' crew members that have terminated their service at a given airport and must go back to another airport assigned by the company as their operative base (*Crew Returning to Base*). Crew members need to hold a certificate issued by their airline stating that the journey is made for service duties.

**Reductions**

Boarding charges for children from 2 to 12 years of age: 50% of adult charge.

**Diverted movements**

In cases where a flight is diverted from the airport originally scheduled for departure to another airport, the charge set at the originally scheduled airport shall apply.

**Freight charges**

They are due from the Carrier, who may claim them back from the shipper.

**1.5 Freight unloading charges** (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

<b>Linate</b>	for each kg or fraction exceeding 500 g.	€ 0.0827
<b>Malpensa</b>	for each kg or fraction exceeding 500 g.	€ 0.0088

**1.6 Freight loading charges** (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

They are the same as those applied to unloading freight.

**Exemptions**

The following are exempted from payment:

- freight unloaded and loaded, in the event of transshipment, within the same airport, from one to another aircraft
- mail
- goods that have been donated, for charitable purposes, to the State, public bodies, non-profit institutes, and organisations
- on-board supplies (fuel, lubricant, foodstuffs, etc.)
- equipment material and spare parts for aircraft in scheduled service.



## 2. SECURITY

### 2.1 Security services (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

They are due directly by the Carrier, who will charge the passenger, as a charge to cover the security screening service costs for passengers, hand baggage and 100% checked baggage

#### **Exemptions**

The following are exempted from payment:

- direct connecting passengers
- children under 2 years of age
- transfer passengers
- free tickets for business trips of Ministry of Transportation staff
- airlines' crew members having their operating base at a given airport that must reach another airport for operational reasons (*Crew Must Go*); airlines' crew members that have terminated their service at a given airport and must go back to another airport assigned by the company as their operative base (*Crew Returning to Base*). Crew members need to hold a certificate issued by their airline stating that the journey is made for service duties.



### 3. CENTRALISED INFRASTRUCTURE

#### 3.1 Loading bridges (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

The charges for the use of the loading bridges apply according to the size of the aircraft and the length of time they are occupied. A standard 60-minutes turnaround time has been defined for both airports.

#### **Night stops**

Night-stop are conventionally handled in the same way as flights with a free stopover time, i.e. between 60' and 75'. The above conventional rate is only applicable within the time frame 23:00-6:59. For the stop-over period outside of this range, the amounts indicated above are charged for each quarter of an hour of exceeding this time band.

#### **Departure only and arrival only**

The fee for **departure only** is 60% of the standard rate:

\* Giovannini Ministerial Decree of 1 September 2022 reiterates that at Linate airport air carriers may operate scheduled flights with narrow-body aircraft. These fees are to be understood only in the event of wide-body aircraft being diverted to the airport.



#### 4. ASSISTANCE TO PASSENGERS WITH REDUCED MOBILITY (PRMs)

##### 4.1 PRMs charge (Regulation EC No 1107/2006 of 5<sup>th</sup> July 2006)

- connecting passengers

- airlines’ crew members having their operating base at a given airport that must reach another airport for operational reasons (*Crew Must Go*); airlines’ crew members that have terminated their service at a given airport and must go back to another airport assigned by the company as their operative base (*Crew Returning to Base*). Crew members need to hold a certificate issued by their airline stating that the journey is made for service duties.

## 5. HANDLING SERVICES

### 5.1 De-icing service for aircraft (effective from 1<sup>st</sup> February 2024 – Ministerial Decree n. 21, dated 30<sup>th</sup> January 2024)

SEA provides the service (use of the platform with an operator) and anti-ice fluid on request.

#### **Note**

De-icing service is carried out by SEA on an exclusive basis in both airports by virtue of the ENAC provisions of January 14<sup>th</sup>, 2021 and September 4<sup>th</sup>, 2023, which respectively assigned to SEA the centralization of the service in subject for the Milan Malpensa and Milan Linate airports.



## 6. AIRPORT FACILITIES

### 6.1 Check-in desk (effective from 1<sup>st</sup> January 2020 – Decree of the President of the Council of Ministers, dated 30<sup>th</sup> April 2012)

The fee for the use of check-in desks with baggage is applied on an hourly basis.
